#### **Unfinished Business/Old Business:**

Make North & South Short Roads into town roads vs private. After looking at the cost to upgrade the road and how much we will get back in road tax, it was determined it would not be in the best interest of the town to do this. We will consider putting some gravel down and grade it annually.

Financing on the Grader – Terry Palecek talked with the CEO of Forward Bank, who said they would structure a loan however we wanted and meet or beat BCPL. Terry will talk with Austin at the local Forward Bank and the Board agreed that if they can meet or beat the BCPL we will go with Forward Bank to support our local bank.

LRIP Committee meeting in Highbridge – Terry Palecek & Dennis Wegner went to this meeting. The Board would like to get together to come up with a 3 year road plan to apply for this grant. Dennis Wegner said we should apply even if we are not at the top of the list in case the towns at the top do not take the grant. This grant is available every other year. Terry Palecek also mentioned the Town should apply for grant money to replace the culvert on the Chippewea. It's a 6 foot culvert and would qualify.

December Meeting – was decided to hold the December meeting on Thursday December 18<sup>th</sup> at 6:30 pm.

Road project for 2026 – The guys would like to know what roads project will be done in 2026 so they can start clearing the roads back this winter. We have to complete the final layer of asphalt on E. Flambeau and double chip seal Cherry and Willow. That will be all the road projects in 2026
